# **OVERVIEW**

The U.S. Department of Transportation's Pipeline and Hazardous Materials Safety Administration (PHMSA) has announced it is issuing Fiscal Year 2022 grants from its Pipeline and Hazardous Materials Safety programs. The grants will be awarded to states, local communities, Tribal entities, and non-profit organizations to support state pipeline and hazardous materials safety programs. Grantees will use awarded funds to train first responders; educate the public on local safety initiatives, including pipeline damage prevention; and develop community incident response plans.

PHMSA provides comprehensive grant programs that are designed to improve damage prevention, develop new technologies, improve both hazmat and pipeline safety. Additionally, both the pipeline safety and hazmat safety grant programs has helped to foster partnerships with local communities, and universities to promote pipeline awareness campaigns, provide resources for emergency preparedness, development of pipeline resources and information, and the implementation of best practices regarding pipeline and hazmat safety nationwide.

### STATE PIPELINE SAFETY BASE AND UNDERGROUND NATURAL GAS STORAGE GRANTS

PHMSA is awarding \$60,000,000 to states through its State Pipeline Safety Base Grant programs for natural gas and hazardous liquid pipelines and \$4,921,433 in Underground Natural Gas Storage Grants for FY 2022 to support states' operating costs for inspecting and enforcing pipeline safety regulations for natural gas and hazardous liquid pipelines and underground natural gas storage facilities. State pipeline safety programs enhance safety by conducting inspections, enforcing the pipeline safety regulations, conducting incident investigations, and taking corrective actions to ensure the safety and integrity of pipelines under their safety authority.

State Pipeline Safety Base and Underground Natural Gas Storage Grants are part of PHMSA's effort to strengthen and retain the federal-state pipeline safety partnership that has existed for many years to improve safety and reduce risk involved with pipeline transportation.

## STATE DAMAGE PREVENTION GRANTS

PHMSA is awarding \$1,663,516 in support of projects in 20 states to continue its commitment to the federal/state partnership in pipeline safety and the Agency's support for their local presence in protecting the public from pipeline incidents and preventing excavation damage. PHMSA has distributed over \$21 million in State Damage Prevention Grants since the program's inception in 2008. PHMSA annually awards grants for state damage prevention to strengthen a state's efforts in addressing pipeline failures attributed to activities such as excavation damage, one of the leading causes of pipeline accidents resulting in fatality or injury.

Additionally, State Damage Prevention Grants are also used to assist states in establishing damage prevention programs where they do not currently exist. State Damage Prevention Grants are designed to establish comprehensive state programs to prevent excavation damage to underground pipeline facilities in states that lack these programs and to improve damage prevention programs in states where these programs already exist. PHMSA offers State Damage Prevention Grants to encourage states to continue implementing the nine elements of an effective damage prevention program, which include the use of effective communications, partnerships, fair and consistent enforcement, training, and technology to help minimize the possibility of negative consequences resulting from excavation damage and inadvertent contact with underground pipelines.

### **ONE CALL GRANTS**

PHMSA is awarding \$1,108,713 in One-Call Grants in support of 36 state damage pipeline damage prevention projects in 27 states. One-Call Grants are designed to improve multiple aspects of state One-Call notification systems, including participation, overall quality and effectiveness, record retention and recording capabilities, compliance and enforcement, public information and education, communications structures that link the systems, developing technologies to locate underground utility facilities, and training personnel. One-Call Grants provide funding to state agencies to facilitate their efforts in promoting damage prevention, such as changes to their state underground damage prevention laws, related compliance activities, training, and public education. One-Call Grants enhance public safety, protect the environment, minimize risks to excavators, and prevent disruption of vital utility services by reducing excavation damages to underground facilities.

## **TECHNICAL ASSISTANCE GRANTS (TAG)**

PHMSA is awarding \$2,157,157 of Fiscal Year (FY) 2022 funding in support for 16 projects in nine states through its Technical Assistance Grants (TAG) program. The TAG program provides funding to local communities and non-profit organizations for technical assistance for local groups and communities related to pipeline safety issues.

TAG funding may be used to help with engineering or other specific analyses of pipeline safety issues, help promote public participation in official proceedings, and increase the scope and quality of public participation in the safe development and operation of pipelines located in and around communities. Informed communities play a vital role in the safety and reliability of pipeline operations; pipeline safety is a shared responsibility. The TAG program targets local communities and nonprofit organizations to advance safety through technical assistance, best practice guidance, and outreach and training programs.

## COMPETITIVE ACADEMIC AGREEMENT PROGRAM

PHMSA is awarding \$4,793,554 (combined) to five universities as part of its Competitive Academic Agreement Program (CAAP) to research new ideas and technologies that will improve the safety of the Nation's energy pipeline infrastructure. The pipeline safety research projects will support PHMSA's mission by promoting technological advancement, increased innovation, and knowledge dissemination to enhance pipeline safety in four research topic areas: Excessive Cathodic Protection (CP) on Vintage Pipelines, Development of Structural Liner Material, Pipeline Infrastructure Modernization – Hydrogen Network and Determination of Potential Impact Radius (PIR) for Carbon Dioxide (CO2) Pipelines.

CAAP was created to introduce undergraduate and graduate students to common pipeline integrity challenges and demonstrate how their engineering or technical backgrounds might contribute to the field of pipeline safety. The goal of the CAAP is to spur innovation and solutions to pipeline safety challenges facing the Nation's pipeline infrastructure through academic research and university student involvement. The projects will further promote industry investment in solutions that improve pipeline safety and protect the environment.

# PIPELINE EMERGENCY RESPONSE GRANT (PERG)

PHMSA is awarding \$1,036,159 in Pipeline Emergency Response Grants (PERG) to six recipients in support of incident response activities related to the transportation of gas or hazardous liquids by pipeline in high consequence areas. The PERG is a new financial assistance program that is designed to encourage a comprehensive approach to emergency planning and training by incorporating the unique challenges of responding to pipeline emergency situations. The grants are awarded on a discretionary basis and are based on an identified need to train responders affected by pipeline incidents. The goal of this program is to promote responder training and community involvement in pipeline emergency response preparedness and response efforts, particularly in high consequence areas. Congress provided up to \$2.5 million for the PERG through the Consolidated Appropriations Act of 2021 (Pub. L. 116-260).
